1. Principal's Message – Bill Richards

Communicable Disease Guidelines

- BC Ministry of Education has rescinded the December 2021 Addendum Provincial COVID-19
 Communicable Disease Guidelines for K-12 settings (Feb 18 at 11:59 pm)
- Return to the prevention measures outlined in the Provincial COVID-19 Communicable Disease
 Guidelines for K-12 settings from Oct 1, 2021

- Points of Clarity
 - o For school gatherings and events that bring together multiple classes or other groupings of students (e.g., school assemblies, multiple classes doing a single activity) from the same school (but members of the school community beyond staff, students and necessary volunteers are not attending), there is not a specific capacity limit.

- For school extracurricular and social gatherings and events that bring together members
 of the school community beyond staff, students and necessary volunteers (e.g., an arts
 club performance, community fair), or that occur between schools (e.g., a music festival,
 a sports game or tournament), indoor capacity should not exceed 50 people or 50% of
 operating capacity (whichever is greater).
 - For indoor spaces without a defined operating capacity, schools should determine a capacity limit that is at most half the number of individuals that would be within the space for that activity or event if prevention measures weren't in place.
- Spectators (e.g., parents, caregivers, peers), may be present for gatherings and events (e.g., attend performance club theatre productions, inter-school sports games and tournaments, etc.) within capacity limits.
- Schools should not implement proof of vaccination requirements for school-led gatherings and events.
- Visitors
 - Visitors are no longer limited to those supporting activities of direct benefit to student learning and wellbeing.

At Burnsview we will Reinforce In-Place Prevention Measures

- Update Burnsview's Communicable Disease Plan
- Reinforce Personal Prevention Practices
 - o Daily Health Checks for students and staff
 - Do not attend school or work if feeling ill
 - o Continue with mandatory mask wearing and proper use of masks
 - Continue with hand hygiene protocols
 - Movement of students and hallway etiquette
 - Continue to have Hallway 1, 2 and 3 doors unlocked for flow of students
 - Locker use before school at lunch or after school
 - Lunch time protocols continue
 - Seated while eating
 - Cafeteria will add seating, classrooms available as well as hallways
 - Mask use immediately after eating
 - Disperse after school in a timely manner
 - Front driveway will be closed to after school pick up
- Field trips will be allowed, however, discussion will need to occur with P/VP and school district senior administration to confirm
 - Outside facilities may have their own vaccine passport requirements
- Each student in public, independent and First Nations K-12 schools will be receiving a box of 5
 Artron Rapid Antigen Tests in Block C Feb 23

 These tests are intended for students in K-12 schools, they should only be used when a student has symptoms of COVID-19

Secondary Futures Working Group

- Group of senior management, administrators and teaching staff from each secondary school responding to the needed shifts in scheduling due to the pandemic
- We've following pandemic schedule the past 3 school years
 - 2019-2020 (online learning)
 - o 2020-2021 (quarter system)
 - o 2021-2022 (semester system)
- Pandemic Shifts 2020-Present
 - Schools were asked to pivot based on health and system requirements
 - Unprecedented ambiguity and lack of clarity for the future
 - Focus on immediate needs of people in the system, vulnerable students, Health care worker students
 - Remote learning challenges
 - Personal stress and challenges for students, families and staff
 - Learning gaps
 - We were looking at building the timetable from the ground up
 - This was difficult (quarter and semester)
- Now the Delta school district has an inspiration to innovate based on the shifting needs during
 the pandemic, along with the district's new Visions 2030, the spirit of innovation in schools (ILT
 and Collaboration time), inquiry (COI), academies, X-Blocks, linear preps in semester schools and
 a commitment to professional learning
- As we look forward to building a framework and schedule that fits the changing environment we are working within, we need to adhere to certain requirements
 - School Act
 - 947 hours of instruction for students grade 8-12 / year
 - Number of hours of instruction per week 27.5 hours
 - Number of minutes of instruction per day 330 min
 - Collective Agreement
 - Legally binding between DTA and Board of Trustees
 - If we need to adjust, modify, or change the language it must be bargained and a formal agreement established
 - Schools cannot alter the calendar without agreement from the union and board
 - Other factors
 - 2 week spring break added minutes of instructional time
 - Could be in violation if too many minutes added
 - Collective agreement 27.5 hours / week of instructional time
 - Collective agreement 330 min / day inclusive of homeroom, transition time, ILT and Collaboration

- Agreement with DTA that school day does not exceed 5 hours 37 minutes per day or 337 minutes per day
- School day cannot by contract cannot exceed 6 hours 30 minutes
- Number of day in the year make up the required time
- We do this each year
- Therefore, there a many factors to consider when deciding the structure to our timetables
 - The working group has met 3 times to discuss important structures
 - Consistencies and inconsistencies within schools and across the district
- Questionnaire to students, parents and staff to gather data based upon specific questions created by the working group
- Timeline is short, decision needs to be made before Spring Break
- Feedback from all stakeholders is very important
- a. Q: regarding school schedule: what courses linear in a hybrid? A: pair common courses (e.g. EN8 and Sciences Humaines 8 or EN 12 with a very common course)
- b. Q: regarding school schedule survey: will results be shared? A: possibly need to discuss; might be easiest to share with PAC

 - a. January minutes not yet available; agenda was simple, mostly COVID and school schedule planning

 - b. District Weekly French Challenge Prizes weekly in the Delta School District's online challenges. (Défi hebdomadaires) The QR codes are posted within the school and on the CPF Delta Facebook page.  - c. **French Immersion Enrollment** Early French Immersion application process has been completed and all families were registered! Current EFI class expectations for 2022: Sunshine Hills 2 classes, Richardson 1.5 classes, Devon Gardens 1 class. Ladner Elementary 2 classes, South Park 2 classes. The Gibson program has been canceled due to lack of enrollment and low class sizes and space availability. The late French Immersion draw is this week as there were more applicants than spots available.
 - d. **CPF BC & Yukon Virtual Conference, February 25-26, 2022 -** Conference is once again online only. Opportunity for Chapter reps and volunteers to collaborate. Delta chapter is registered so any
